Issues like,

- > lack of support and coordination,
- provision of transport for meetings and other forums,
- ➤ no invites for strategic meetings like the IDP Rep Forums,
- > Economic empowerment,
- ➤ Lack of houses
- > Access to government buildings
- ➤ Skills development for people with disabilities so that they can be employed in our municipalities, should have been addressed by now.

Programme Director, in all the intergovernmental Relations Forums and IDP Rep Forums, I raise this issues because of the passion I have for the plight of people living with disabilities.

As I said before, South African can only be free if ALL South Africans are free.

We cannot afford to tarnish the achievements we have made as we celebrate the 27 years of democracy. Our democratic government, led by the African National Congress has done more to create a better life for all without discrimination. South Africa has come a long way in addressing injustice, inequality and poverty.

Programme Director, our society has been transformed in every sphere since 1994. The Census results indicate that income levels have increased, education levels are up and millions of people have access to water, electricity, sanitation and housing.

Let us go and vaccinate and those who already vaccinated, let's please go for the Booster and remain safe. Covid19 is still living with us.

Let's continue to wash our hands regularly, keep social distance and always wear our masks.

Let us make this day special for ourselves and ALL Persons with Disabilities.

Working together we can do more to break barriers and open doors to realise an inclusive society through partnerships.
